## **TOURNAMENT RULES**

- 1. TOURNAMENT HOURS ARE 7:00PM JULY 15, 2023 UNTIL 6:30AM SUNDAY, JULY 16, 2023
- 2. ALL BOATS MUST BE IN BUOY AREA BEFORE THEIR DESIGNATED TIME OR BE DISQUALIFIED.
- 3. ALL FISH BROUGHT TO THE WEIGH-IN (EXCEPT TROPHY BASS) WILL BE RETURNED TO THE WATER.
- 4. ONLY LARGEMOUTH, SPOTTED AND RED EYE BASS WILL BE WEIGHED.
- 5. MINIMUM LENGTH TO BE WEIGHED SHALL BE (12) TWELVE INCHES ON THE GOLDEN RULE. ANYONE WEIGHING IN A FISH SMALLER THAN TWELVE (12) INCHES WILL BE PENALIZED BY CULLING THEIR LARGEST FISH.
- 6. THERE IS A 5 FISH LIMIT PER BOAT. BRINGING MORE THAN 5 FISH TO THE SCALES WILL RESULT IN DISQUALIFICATION.
- 7. NO TROLLING, JIGGER-POLING, LIVE BAIT OR WADING. ARTIFICAL LURES ONLY.
- 8. CONTESTANTS WILL ABIDE BY ALL APPLICABLE ALABAMA WATER SAFETY REGULATIONS.
- 9. ONE CONTESTANT'S BOAT CANNOT FISH OR ANCHOR WITHIN 150 FEET OF ANOTHER CONTESTANT'S BOAT.
- 10. CONTESTANTS WILL WEAR A LIFE JACKET AND HAVE A KILL SWITCH ATTACHED TO THEIR PERSON WHEN THE GASOLINE ENGINE IS RUNNING.
- 11. NO ALCOHOLIC BEVERAGES WILL BE ALLOWED DURING TOURNAMENT HOURS.
- 12. A MAXIMUM OF ONLY 2 DEAD FISH WILL BE ALLOWED. BRINGING MORE THAN 2 DEAD FISH TO THE SCALES WILL RESULT IN AUTOMATIC DISQUALIFICATION.
- 13. WINNERS MAY BE REQUIRED TO PASS A POLYGRAPH TEST TO QUALIFY FOR PRIZE MONEY.
